## WEB SITE REVIEW by Lowell Benson.

This is the fourteenth in the series of ‘Article for the Month’ reviews for the 37.4% of our Club members who don’t have immediate internet access.

In February, 2010 we posted "[The almost Silicon Valley](#)" by Tom Webb - Used with permission, originally published in the 1-3-2010 St. Paul Pioneer Press.

This was a great article for us as the Press front page led readers to the business section with: “Remembering when St. Paul was the cradle of the computer industry.” Our VIP Club Legacy Committee co-chair, John Westergren had read an Armour Company ‘history article’ in the Pioneer Press the summer of 2009. John called the author, Tom Webb, to suggest that Engineering Research Associates (ERA) could be a good topic for an article. Mr. Webb researched ERA at the Charles Babbage Institute then interviewed the following people from a list provided by Lowell: Dr. Tom Misa, Don Weidenbach, Paul Nikolai, Jack Ross, Jerry Williams, Harvey Taipale, and John Westergren.

In March, 2010, we posted "[Legacy' at the University of Minnesota](#)" by Lowell Benson. This paper is a description of the Legacy Committee’s artifact and document exhibit which was on display in the University’s Walter Library from mid January to mid-May. The primary section of the display used some of our sesquicentennial posters supplemented with the ERA to UNIVAC relationships with the University including the 1958 delivery of an 1103 computer to begin the foundation of their Computer Science department. The secondary section of the display focused on the evolution of memory technology which began with the ERA drum memory. The U’s Computer and Electrical Engineering facilitated the paper work required to bring the display to the University.

## CALL FOR WOMEN IN COMPUTING by John Westergren

The Legacy Committee has been attempting to document our Information Technology (IT) history here in Minnesota. We started long before last fall’s LMCO Eagan plant closure announcement, but that announcement has added additional emphasis to our efforts. You can see some of the results on the website: <http://vipclubmn.org/lmcolegacy.aspx>

We are working with the University of Minnesota, Charles Babbage Institute (CBI), Center for Information Technology to store historical items in their archives, also to document additional items of a historical nature. If you go to their website (<http://www.cbi.umn.edu/>) you’ll see that one of their many pages is an Oral History Page, an extensive collection of oral histories which they’ve gathered over the years from people associated with the Information

Technology industry here in Minnesota and around the world. In discussions with Dr. Tom Misa, CBI Director, he has said that they are lacking information about women associated with the early years of IT and manufacturing. I suggested to him that we had a number of women still employed and retirees that would make excellent, potential candidates and might be willing to be interviewed. He agreed! The Legacy Committee has reached out to Lockheed Martin and UNISYS employees, but we also want to make sure that the wealth of experiences from the Retiree population is considered.

So first, please let me know if you'd be interested in participating. It is strictly voluntary and it might be fun. Second, if you are interested I'd ask that you put together a short, abstract like, document which highlights your career. For this first effort it doesn't have to be long. Here are some questions to answer:

- Why did you come to work at Sperry/Legacy company?
- What was your first job and subsequent jobs leading to today's work?
- Short paragraph on the changes you've seen in the workplace?

If you want some additional ideas, there are over a hundred Career Summaries of every type and style on our website (<http://vipclubmn.org/Authors.aspx>.) The abstract I'm asking from you doesn't need to be as lengthy as some of those, but they might trigger your memories and thoughts. Next, I'll review the abstracts you provide with Dr. Misa at CBI. We'll use them to formulate some additional questions in an interview format. We'll share those questions in advance so you'll have some time to think about them prior to any interview.

Then we'll schedule some interview time with those of you interested. Once an interview is completed and transcribed, a hard copy will be provided for your editing and concurrence. Finally, if you're OK with the results, it will be posted to the CBI website as part of the Lockheed Martin or UNISYS history and we'd also ask your permission to have it posted to the VIP Club Legacy website.

Please consider this opportunity to provide some insight to what life was like in the early years of the IT industry from your perspective. Thanks for considering this and please let me know your interest.

## CONSTITUTION CHANGE BALLOT

At the Club's May 4<sup>th</sup> Board meeting we passed a motion to submit Constitution amendments to you, our membership, for approval as required by the Constitution, section VII. The current Constitution and Bylaws are available on-line from section 1 of <http://vipclubmn.org/About.aspx>. The Constitution was last updated in 2000 when Lockheed Martin requested that they become a co-sponsor along with UNISYS. The Constitution amendment approved recommendations are:

<b>III GOALS</b> ... The CLUB shall provide a forum for information on the heritage and on-going action of the sponsoring business entities and their predecessors.	<b>III GOALS</b> ... The CLUB shall provide a forum for information on the heritage and on-going action of the heritage companies (Twin Cities based Univac/Unisys organizations and the predecessor and successor firms).
<b>IV MEMBERS</b> are former employees and their spouses of Twin-Cities-based Univac /Unisys organizations and predecessor or successor business enterprises who are retired, or eligible to retire and are no longer employed by one of the sponsor organizations. ...	<b>IV MEMBERS</b> are former employees and their spouses of Twin-Cities-based Univac /Unisys organizations and predecessor or successor business enterprises who are retired or eligible to retire, and are at least 55 years of age. ...

These Twin Cities Sponsor organizations are rightfully interested in promoting their images as citizens of the community and in providing benefits for employees and retirees.
