# MAY PROGRAM: The Value of DNA Testing

Are you descended from explorer Leif Erikson or first king of Norway Harald Fairhair? How about Charlemagne, Genghis Kahn, or a Neanderthal? So what's the value of DNA testing, the real value for real people like those reading this right now? This year's Norwegian Syttende Mai lunch presentation will answer those questions.

Regardless of the Norwegian "content" in your DNA, please join us at Casper's Cherokee Sirloin Room in Eagan, Friday May 15<sup>th</sup> at 11:00 for the annual LM/Unisys Syttende Mai lunch. a delicious buffet and an intriguing program. In of 1999, Dixie Mav Hansen spoke on the topic of the newly emerging Internet resources for the purpose of genealogy and specifically for Norwegian genealogy. Dixie, a board member of the Norwegian-American Genealogical Association,



returns after 16 years to discuss the value of DNA testing. Do you think you know who you are? Your DNA does!

In our speaker's words: "Dixie Hansen, a long-time family historian and a bit of a computer nerd, has very eagerly played with all of the cool new software and internet tools for digging into the past which have emerged in the past 20 years. One of the more recent and useful tools is Autosomal DNA analysis ... a way to explore personal ancestry from a way different vantage point. All it takes to get started is a little bit of spit and \$99 or so. In the interest of learning what it was all about, Dixie (always an early adopter) submitted her DNA to three of the major US genealogical testing services: 23 and Me, Ancestry DNA, and FamilyTreeDNA.

Unlike earlier YDNA and mtDNA tests - which primarily give a family historian clues into their very deep long ago ancestral past and then only on straight paternal or maternal lines, Autosomal DNA gives the researcher scientific clues about ALL of their ancestral lines and reliably helps them identify living cousins and, through those cousins, common ancestors in the last several generations. All three companies also give you a report (though this science is still fairly rudimentary) of your ethnicity and the likely geographic origins of your family. Autosomal DNA testing is easy, it's practical... and, with a little bit of work, it can definitely help you add to your family tree. As importantly, it can support (or challenge!) the accuracy of work you've already done through more traditional research. Maybe your DNA will tell you something about your family that you weren't expecting? If you don't want to know, don't look!

Dixie has futzed with the various computer tools that each of the three testing companies provides to help the family historian make sense of their DNA test results. She'll give you a tour of the tools and cousin-matches and will explain what to expect if you are inspired to spit." Submitted by Richard Lundgren.

# Astronauts Could Depend On Reliable Univac Computers

Highly reliable Univac 1218 Computers operated a total of 910 hours during the historic Gemini 4 space mission earlier this month — without a single failure.

Twelve 1218's, strung out at bases surrounding the earth, kept track of information within the capsule and the astronauts' physical condition during the four-orbit flight.

The computers summarized and stored the data that was beamed to the ground from the capsule. The data was transmitted for final processing on two Univac 490 computers at Goddard space flight center, Greenbelt, Md., and the Houston mission control center.

The systems also enabled the National Aeronautics and Space Administration controllers at Goddard to select and examine specific in-flight information such as the astronauts' pulse beat, blood pressure and temperature, on a real-time (no delay) basis. The 1218 computers, made in Univac Plant 3, are installed at

The 1218 computers, made in Univac Plant 3, are installed at Cape Kennedy; Bermuda; the Canary Islands; Corpus Christi, Texas; Guaymas, Mexico; Kauai, Hawaii; Carnarvon, Australia; Wallops Island, Va.; Greenbelt, Maryland, and aboard two tracking ships on the Atlantic Missile Range.

The Instruction Set Architecture (ISA) and basic logic design for the 1218 came from a Computer Unit Tester developed for internal factory use. The first units were built using PC cards from the CP-642 computer. Well over 1,000 computers were delivered with this basic 18-bit ISA including the commercial 418 series. Defense computer ID numbers were the CP-789, CP-848, 1819, and AN/UYK-11. By LABenson

# DIRECTIONS TO ACTIVITY VENUES

Car-pool if possible to all events or contact a board member for possible 'ride-with' suggestions.

**Directions to UNISYS MACS building in Eagan:** Set your GPS unit to Eagan MN, 3199 Pilot Knob Road. <u>From</u> <u>Hwy 35E</u> take the Pilot Knob Road exit ramp. Then go north on Pilot Knob Road about  $\frac{1}{2}$  mile to Tower View Road. We use the Unisys north parking lot and the visitor entrance thereby.

**Directions to UNISYS in Roseville:** Set your GPS unit to Roseville MN, 2470 Highcrest Road. From Hwy 35W north; exit onto W County Rd C to go west a mile, then turn left onto Walnut St. Then turn right onto Terminal Road for half a block, turn right at Highcrest Rd. to building entrance. From 35W south, exit on Industrial Way / St. Anthony Blvd off ramp, turn left, drive under the freeway, then turn right onto Walnut St. Follow it 0.8 mi north then turn left on Terminal Road. Go ½ block and enter the UNISYS parking lot on the right. From Hwy 36 east, drive west until 36 joins Hwy 35W just past Hwy 280, then exit at the Industrial Way / St. Anthony Blvd. off ramp of 35W. Go north on St. Anthony Blvd. to Walnut St. [the first street on the right]. Turn right onto Walnut Street. From Hwy 280 northbound, use left lane exit just past County Rd B for Terminal road access [St Croix St.] Turn left at Terminal Rd, then 1.5 mi to Highcrest Rd.

**Directions to Casper's Cherokee House in Eagan:** Set your GPS unit to Eagan MN, 4625 Nicols Road, <u>From I35E</u>, take the Cliff Road exit and go west to Nicols, turn left. <u>From Cedar Ave</u>, take the Cliff Road exit, go east to Nicols, and turn right.

**Directions to Mermaid in New Brighton:** Set your GPS unit to Moundsview, MN - 2200 CR 10. From <u>Minneapolis</u>, other southwest points, and <u>Roseville</u> - take I35W north then at exit 28C take ramp right for CR10, cross over the bridge then turn left onto Co. Rd H. <u>From Eagan</u> and southeast points - take I35E north to I694 West, keep in the right lane for Hwy 10, get into the left lane, cross over I35W, then turn left onto Co Rd H.

**Directions to Highland Park in St. Paul:** Set your GPS unit to St Paul, 1200 Montreal Ave. From the Roseville area; take 36 to 35E going south through the city, exit at W 7<sup>th</sup> (Hwy 5) and turn right. After three blocks angle right onto Montreal Ave and drive uphill ½ mile. The Pavilion is on the left. From the Eagan area take 35E north toward St. Paul, exit at W 7<sup>th</sup> (Hwy) 5 and turn left. Proceed to Montreal Ave angling right and drive ½ mile. From St. Paul, find Snelling Avenue, drive south to Montreal Ave then turn left. Drive ¼ mile to Pavilion on right. Shuttle bus parking is at the High School, Snelling and Montreal.
