**UNIHOGS & Technologists Reunion** - We gathered at Casper's in Eagan on November 6<sup>th</sup> to hear an interesting presentation about Unisys and the Minnesota High-Tech Association (MHTA) by Unisys Director Charles Lefebvre. Unisys recently sold a 2200 system to Carnival cruise lines; each time a guest uses an ID card for cabin access or an on-board purchase - a UNISYS computer knows it! The UNISYS systems still run Exec-8 operating system (OS) that began with the 1108 dual processors in the late 60s. In response to questions, Chuck stated that the OS still executes Fortran as part of airlines freight management systems.

There are over 350 MHTA member companies who cooperate and compete in business. They have two ongoing initiatives; promoting STEM and statewide internet access. We do need more females and minorities in the technology industry!
