

#### President's Message

For five and a half years I have been privileged to serve as president of the UBBRG.

Since the passing of Joe Campbell, Jerry Feldscher, Mary Pacifico, and John O'Brien, the executive board has been functioning without a Vice President or Travel Chair. These officers were a stabilizing force which has been sorely missed. For the future of UBBRG, this is a matter of great concern.

The Blue Bell Retirees' formed in 1988 originally as a social group. It soon took on the matter to settle a dispute over medical coverage for Unisys retirees'. With this incentive, membership grew to approximately 1800 members which resulted in substantial turnout for the meetings. The dispute has long been resolved and interest in the group has waned.

Membership currently is at 637. This is because, “long time faithful members”, whose numbers are declining,

have continued to renew their membership. The marked reduction in Blue Bell retirees' and the lack of interest has greatly impacted the recruiting for new members. Although these numbers are impressive, the executive board has not been able to find anyone willing to become a member. To replace any of the executive chairs requires significant time and effort.

This involves learning programs to publish NEWSBITS, record membership details, keep the Website up to date, and manage the treasury.

The executive board has not been able to over-come the afore-mentioned problems and met in January to discuss these issues. The following, while not easy to make, are steps the board has voted to take:

- UBBRG to be dissolved by December 31, 2016
- Discontinue general meetings at Plymouth Mall
- NEWSBITS and the [ubbrg.org](http://ubbrg.org) website will remain active through 2016.

The executive board will remain active and will meet at regular intervals through-out 2016. Communication to the membership will continue through NEWSBITS and the [ubbrg.org](http://ubbrg.org) website. If you would like to send comments, questions or suggestions to the executive board, they will be published in the June edition of NEWS-

BITS. I will attempt to answer your queries as best I can.

## Monthly Meeting Guest Speakers

**December's** guest speaker was Dr. Grover, ophthalmologist, who spoke about the eye health and eye problems.



The following were the major topics:

- Cataracts
- Glaucoma
- Age-Related Macular Degeneration
- Diabetic Retinopathy

## Cataracts

A cataract is a clouding of the lens in the eye. The normally clear lens lets light enter the eye. As it becomes cloudy, less light enters and vision becomes blurry. Cataracts are common with age and can occur in one or both eyes. The

clouding of the lens usually happens slowly over time. But it can happen quickly as well.

### *What Causes Cataracts?*

Cataracts may be caused by many things, such as:

Aging, Diabetes, Past eye infections, injuries, surgery, and some medications (such as steroids), too much ultraviolet (UV) light, especially from sunlight, family history of cataracts, and tobacco use.

### *What are the Symptoms?*

Cataracts are not painful. But you may notice these symptoms:

Blurry vision, details are hard to see, glare when driving or reading, more light is needed to read, some colors seem faded, your prescription for glasses keeps changing, and double vision in one eye.

### *If you have cataracts take these steps:*

Have eye exams as often as suggested by your eye doctor.

If cataracts limit your daily tasks, talk to your eye doctor about treatment. Surgery can often restore our vision. You can usually return to our daily tasks soon after.

## Glaucoma

Glaucoma is an eye disease that can cause blindness. If caught early, it can usually be controlled. But it often has no symptoms, so you need regular eye exams. Glaucoma usually begins when pressure builds up in the eye. This pressure can damage the optic nerve. The optic nerve sends messages to the brain so you can see. There are two main kinds of glaucoma: open-angle and closed-angle.

### *Open-angle Glaucoma*

Open-angle is the most common kind of glaucoma. It occurs slowly as people age. The drainage area in the eye becomes clogged. Not enough fluid drains from the eye, so pressure slowly builds up. This causes loss of side (peripheral) vision. But the loss is so gradual, you may not even notice it.

### *Closed-angle Glaucoma*

Closed-angle glaucoma is less common than open-angle. It usually comes on quickly. The drainage area in the eye suddenly becomes completely blocked. Eye pressure builds rapidly. You may notice blurred vision and rainbow halos around lights. You may also have headaches, nausea, vomiting, and severe pain. If not treated right away, blindness can occur quickly.

### *Get an Eye Exam*

The best way to catch glaucoma early is to have regular eye exams. During the exam, your eye doctor checks your eye pressure and to view the drainage areas and optic nerve. Your doctor also checks your visual field (to be sure you're not losing side vision. Additional tests may also be done.

**Glaucoma**

*Who's at Risk*

Anyone can get glaucoma. But some people are more likely to get it. Risk factors include the following:

- Increasing age
- African ancestry
- A family history of glaucoma
- Previous eye injuries or surgeries
- Health problems such as diabetes or high blood pressure

*Treating Glaucoma*

Treatment can prevent or limit vision loss from glaucoma. The goal of treatment is to control glaucoma by lowering eye pressure. Your doctor can suggest what treatment is best for you. You may just need more frequent exams. Medications and procedures to improve eye drainage may also help.

**Age-related Macular Degeneration (AMD)**

*What Is Age-Related Macular Degeneration?*

Age-related macular degeneration (AMD) is an eye disease. It is a leading cause of vision loss in adults after age 50. One or both eyes may be affected. The **macula** (the part of the retina that produces central, detailed vision) becomes damaged. Central vision becomes limited. However, side vision remains clear. There are two types of macular degeneration: dry and wet.

*Dry Macular Degeneration*

Dry is the most common type of macular degeneration. In the early stages, changes in vision may be hard to notice. Over time, your central vision slowly worsens. You may notice wavy lines and blank spots in the center of your vision. Colors may look dim. There is no way to restore vision lost from dry macular degeneration. But you need to monitor it because it can turn into wet macular degeneration.

*Wet Macular Degeneration*

Wet macular degeneration is less common but more serious. Vision loss is quick and severe. You may suddenly notice dark spots, blank spots, wavy lines, and dim colors in the center of your vision. If wet macular degeneration is caught early, laser treatment may help slow further vision loss.

Again, to get the best out of your vision is to have regular eye exams

**Diabetic Retinopathy**

Diabetic retinopathy is the leading cause of blindness in U.S. adults. It occurs when diabetes weakens blood vessels inside the eye. These weak vessels leak fluid into the inside lining of the eye, called the **retina**. New, abnormal vessels may grow, then bleed. This can damage the retina, causing blurry, distorted vision.

**Diabetes** is the cause of this disease. Over time, diabetes makes blood vessels weaken all over the body, including in the eyes. Other things can combine with diabetes to make retinopathy worse. These include pregnancy, high blood pressure, and smoking.

You can have diabetic retinopathy without knowing it. Usually, there is no pain and no outward sign. Over time, you may notice gradual blurring or some vision loss. Symptoms may come and go. If diabetic retinopathy is severe, you may have clouded vision or blindness.

Harvey, who grew up in the Bronx, NY, met Marilyn Teitel, who was from Brooklyn, NY, in the summer of 1959 in the Catskill mountains in an arranged blind date setup by a friend of Marilyn's and one of Harvey's brothers. The weekend went well and they fell in love. They were married on February 20th 1960.

Harvey and Marilyn are survived by their four sons and their respective wives/partners: Brian & Judy, Lou & Karen, Harris & Mike, and Dan & Sharon. They are also survived by their beloved grandchildren, Meagan and Kevin - who are Lou and Karen's children. The immediate family and extended family were so important to Harvey and Marilyn and were a source of great pleasure throughout their lives.

Harvey's was a life full of activities, hobbies, and pursuits. From morning to night. Every day! From racquetball and softball and other sports in earlier years, to golf, fishing, traveling, pool shooting, and many other activities, he remained in nearly constant motion. And of course there was his music; more on that later. He had an active life during his working days and the fun intensified when he retired in

December of 1989 at the age of 57. He loved to have fun, be busy, and get things done.

Successively living in New York, New Jersey, Maryland, and Pennsylvania while they raised their family, Harvey and Marilyn moved to Clearwater Florida shortly before Harvey retired. His love and knowledge of music extended to many genres and in different forms including his large collection of 1900 - 1950s popular music sheets to his collection of classical music on old vinyl 38's. Oh, how he loved the music, but equally he loved the countless people with whom he made music and shared the love of music.

His love of his activities and people continued right up until his last days. True to form, after he lost Marilyn in May of 2013, he kept living, laughing, playing, and loving. Harvey was greatly fortunate to meet Olga Fisher with whom he came to share a deep love in the last years of his life and together they shared so much in too short a time.

Harvey Maslowe was a man of many talents and dimensions. He was very generous in many ways and was caring, funny, enlightened, and wise. 
