WEB SITE REVIEW by Lowell Benson.

This is the twelfth in the series of 'Article for the Month' reviews for the 42.3% of our Club members who don't have immediate internet access. A year after our Legacy project began, the committee asked Earl Vraa to document the UNIVAC experiences with Automated Design. Earl provided us with three papers which had been presented at conferences. He then created an outline and contacted several people who collaborated on telling our Computer Aided Design Story. Last month's issue summarized the first two papers – below are parts of the third paper and 'the rest of the story.'

In August 2009 we posted a 1986 paper, "A System Through Hardware Design Methodology" written by Larry D. Anderson and Earl M. Vraa. Selected excerpts are: "Sperry's entry into the Department of Defense's (DoD) Very High Speed Integrated Circuit (VHSIC) program enhanced our understanding of at least two issues important in Sperry's business planning. The issues include 1) the dangers of complacency with respect to technology advancements and 2) our strengths with respect to the development of cost and technically competitive electronic products." "... DoD requested a "hierarchical chip design methodology for use with computer aided design (CAD) facilities." The CAD tools were to "support the entire design process including functional definition, design, implementation, functional verification (and) physical verification." The CAD tools were to be "integrated with a unitized data base into which data items need be entered only once and are then available to all tools and aids within the CAD system." "Discussions between the authors and several members of industry (e.g., RCA, Hughes, Westinghouse, TRW, TI, etc.) indicate *all* have some level of activity underway to better understand the concept of hierarchical design and its impact on new and existing CAD tools." "... presentation covered the utilization of ULYSSES in the design of a 24-bit adder for the Sperry Micro 1100 processor." "The concept of hierarchical design as supported by CAD tools is complex and will continue to evolve. In this paper, the authors have attempted to illustrate what we see occurring. Many of the ideas expressed have been borrowed from those people with whom we have been privileged to work including Mr. Mark D. Glewwe, Mr. Allan W. Kiecker, Mr. Dean R. Kioker, Mr. Steve J. Piatt, and Mr. John J. Travalent. Thank you for your contributions."

In November 2009 we posted: "EVOLUTION OF MECHANIZED DESIGN, AUTOMATED DESIGN,

COMPUTER-AIDED DESIGN AT ERA, REMINGTON RAND, UNIVAC, AND SPERRY" *from the early-1950s to late 1980s – as compiled by Earl M. Vraa.* Contributors: John Alton, James R. Andrews, Keith Behnke, Curt Bute, John Esch; W. Burt Horsted; John J. Travalent, and Earl M. Vraa. A meaningful 'recap' of this 18 page paper covering 30 years would be useless. In addition to the contributors, the people mentioned therein are almost like a Who-is-Who book: Seymour Cray, Wally Eidahl, Howard T. Engstrom, Robert 'Bob' A. Erickson, Leland A 'Lee' Granberg, Stan Halper, Joe Kimlinger, R. Kisch, Bruce Klugherz, Bob Lawler, Wayne Leverkuhn, Ralph. I. Meader, Milton (Milt) Montgomery, Jerry Neese, William C. Norris, Wayne Olson, John Parker, Red Phillips, Kenneth J Thurber, Al Wald, and Paul Welshinger. Systems noted were: AUTOGRAM, AUTOVG, BISON, CAMIDS, DODO, FLOWCHARTS, INDICATES, LAMPS, LOCATES, MIDAS, MIXSIM, NETTERHELPER, OPTIMA, PERT, SIM-LOGIC, SLATE, SNOOP, and TEKGERBER.

FACT OR FICTION, ANOTHER LEGACY COMPUTER?

While on Maui in February, I read "Blind Man's Bluff" by Sherry Sontag and Christopher Drew. Three extracted paragraphs are:

- from page 86: "There was a dark room, a data analysis room, and a computer room stuffed with one massive computer: the Univac 1124. It was a huge machine with big tape reels and blinking lights, and it gave the cavern [bat cave] the feel of the science fiction-adventure realm for which it was named. (Still, Univac had only a tiny fraction of the power of the average modern laptop.)"
- from page 88: "The computer's 'Interleaf' operating system needed more than the computer's 32 kilobytes of memory to operate. When computer components in the fish [U.S.S. Halibut] failed, new ones were secreted into Pearl Harbor in the luggage of American Airlines stewardesses."
- from page 99: "Things became even more difficult when the Univac 1124 crashed."

From a Wikipedia sections about the USS Halibut, I'd guess that this 1124 system was installed about 1965. Do any readers remember anything about this computer or the 'Interleaf' operating system? If yes, please contact a board member or one of our legacy committee members. Thanks, Lowell

LEGACY COMMUNICATIONS WITH MARCH

The Mid-Atlantic Retro Computing Hobbyists (MARCH) recently acquired a 1219B system, they are looking for volunteer technical assistance. Our Legacy Committee sent them a Technical Description booklet from our collection. If any of our readers would be willing to give them any further technical advice, it would be much appreciated. Their system acquired last year from the Johns Hopkins University Applied Physics Laboratory consists of two #1219B CPUs, two #1540 tape units, four #1533 teletypes, four #1532 I/O consoles, one interconnection panel, and one #2008 data transmission unit. They'd like to find a #1551 alphanumeric display unit, a #1569 high-speed printer, and a #1549 card reader-punch-interpretter to make a complete operational system. Does anybody know where we could find any of these peripherals? LOCKHEED MARTIN RETIREE BENEFITS

Some of you have inquired about the availability of Lockheed Martin's employee discount program, which is available to LM retirees. The latest information can be accessed thru the Lockheed Martin web site: www.lockheedmartin.com. On the home page, mouse over "About us" then "Employees/Retirees Pay and Benefits" and click on "Retirees." This will redirect you to a login screen for various benefits information sites. Click on either "Health or Life Coverage" or "My Pension Payments" and you will be directed to a secure login screen (<https://www3.benefitsweb.com/lmc.html>). Log in, and you will see a tab under the Lockheed Martin banner that is labeled "Retiree Discounts" click on it to access the retiree discount information page. Click where indicated to get either a directory of available discounts or more information about the discount program.

Of course, if you wish, you can bookmark the secure login URL and go directly there without accessing the Lockheed Martin public site.

Getting there takes a little work, but there currently are about 75 different discount offers for a variety of things including services, computers, appliances, automobiles, and memberships, along with specific instructions for accessing them. Submitted by Harvey Taipale.

HEALTH ISSUES

How soon we forget. Back in 2003 the Medicare Modernization Act gave us a Part B with a "Welcome to Medicare" physical, higher monthly costs, more deductibles, and bigger co-pays. It gave us a Part C Medicare Advantage HMO option that paid insurers up to 18% more than the old 80% reimbursement/20% out-of-pocket that traditional fee-for-service offered. It

also imposed a Part D Prescription Drug Benefit that was fully paid for by the enrollee, and if the Medicare enrollee did not sign up for the drug benefit at first eligibility the cost of the drug insurance increased at 1% per month – call that a mandate with a real penalty. This is the “benefit” program with the “donut hole,” where you paid for the insurance even when you received no benefit. We did not get regional reimbursement equity, we did not get more evidence-based medicine, we did not save on prescription drugs, and we certainly did not get any simplification of the program.

The 2010 Affordable Care Act with its mandate to buy insurance uses a smaller club in its attempt to get more people covered but hopefully will prevent more people from losing insurance or having procedures denied. To call it “Obamacare” is less than true. It is simply an expanded version of “Massachusettscare” enacted in 2006 under then-Governor Mitt Romney that expanded private insurance by adding requirements and incentives to encourage residents to have some form of insurance. Our new law does expand the Medicaid program for the poor, extends coverage for older children, and eliminates denial of coverage to those with existing medical conditions. But mostly it compels people to buy insurance that still may be unaffordable and pay drug prices that the pharmaceutical companies have set. Doctor payments will not be cut, but primary care docs will continue to be underpaid and specialists will continue to be overpaid. If it had provided for a “Public Option” and mandated negotiated drug prices as the Veterans Administration does we would have had something to help with care. What we have now is another healthcare act that is again more about insurance than healthcare and that has too many moving parts for anyone outside the industry to understand. Congress has done to our children with the Affordable Care Act what it did to us with the Medicare Modernization Act. Submitted by Brian Berggren.
